

IMPORTANT ANNOUNCEMENT TO THE
PEOPLE OF ERITREA

RE: “ Government of Eritrea in Exile”.

It is to be remembered the splitting of the umbrella organization Of the Eritrean forces for democratic change(EDA) into 3(three) Blocs in the beginning of year 2007.This splitting in to Blocs Caused a lot of confusion and frustration in our Struggle for Democratic change. A few determined Eritreans convened on 30-08-2007 in Toronto-Canada to asses the situation.After discussing it thoroughly, they Established a “ Government of Eritrea in Exile” and Appointed Memhr/ Tesfagaber-Asfaha-Keflinkiel as its President, as a way forward for our struggle for Democratic change in Eritrea. Our struggle continued. At the end Of year 2008 and beginning of 2009, the Rebellion of the Eritrean Defense Forces against dictator President Isayas-Afewerki Occurred.This was a window of opportunity for the success of our Struggle for democratic Eritrea.To seize that opportunity, the “ The Government of Eritrea in Exile” declared a “ Transitional Government of Eritrea on 16-04-2009 and tried to connect the diaspora struggle with the Rebellng Eritrean defense forces by forming an Executive Cabinet made of 50% from the diaspora struggle and 50% from the Rebellng defense forces of Eritrea. Our struggle continued. In the year 2010 convention made of diaspora civil-society and the opposition political forces was held In Adis-Ababa Ethiopia . As a result a commission was established, its mandate was to organize and prepare Congress of diaspora civil society and the opposition political forces of Eritrea.

Our struggle continued.At the end of year 2011 congress made of Diaspora Eritrean-civil society and political opposition forces of Eritrea Convened in Awassa Ethiopia.As a result Eritrean council For Democratic Change(ECDC) made of 127 persons is Established.

Now, we are at this stage of our struggle for Democratic Eritrea, and we continue.

The ' Few, but determined Eritrean fighters for democratic Eritrea of Toronto/2007 and many more other Eritreans convened again in Toronto-Canada on 25-03-2012 to asses the:

- 1) Government of Eritrea in Exile
- 2) Transitional Government of Eritrea.

After discussing and debating it carefully and thoroughly, they made the following decisions:

They Dissolved both the 'Government of Eritrea in Exile' and the 'Transitional Government of Eritrea'. That is, effective 25-03-2012 the Government of Eritrea in Exile and the Transitional Government of Eritrea are officially dissolved,they do not exist any more.As a result of this Memhr/ Tesfagaber-Asfaha-Keflinkiel is no more president of Eritea in Exile or 'Tansitional Government of Eritrea'. He is one of the 127 members of the Eritrean council for democratic change(ECDC).
